- 4. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document. EMD Payment: The bidder shall be required to submit the Earnest Money Deposit (EMD) for an amount of Rs. 6,793/- (Rupees Six Thousand Seven Hundred Ninety Three Only) by way of demand drafts or Bank Guarantee (valid upto 180 days from submission) only payable at Jodhpur. - 1) The rates quoted must be valid for 90 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- 2) Right to issue and to accept or reject any or all tenders without assigning any reason thereof is reserved by the Competent Authority.
- 3) **Award of Contract:** The Institute shall consider placement of orders for jobs on those bidders whose offers have been found technical and financially acceptable. The Institute reserves the right to counter offer price(s) against price(s) quoted by any bidder.
- 4) **Signing of Contract**: The successful bidder shall be required to execute the Contract Agreement accepting all terms and conditions stipulated herein on a non-judicial stamp paper of Rs. 500/- (Rs. Five Hundred only) and submit performance security within seven days of the issue of the work order. In the event of failure on the part of the successful bidder to sign the Contract within the period stipulated above, the EMD shall be forfeited and the acceptance of BID shall be considered as cancelled.

5) Performance bank guarantee:

- a.
