The EMD of Rs.16,300/- and non-refundable bid submission fee of Rs. 1550/- (including GST) shall be remitted online through e-payment facility (**SBI MOPS Gateway only**). Bidder should ensure that bid submission fees and EMD are remitted as one single transaction and not separate. Separate or split remittance for bid submission fee and EMD shall be treated as invalid transactions.

The offers shall be submitted in single Bid system. All Bid documents are to be submitted online and in the designated covers/envelops on the above website. Bid shall be accepted only through online mode in the website and no manual submission shall be entertained.

The scanned copies of EMD, all agreements executed in Kerala Govt. stamp paper worth Rs.200/- in each and all certificates/documents mentioned elsewhere in the bid documents are to be attached along with the bid through online. The bid will be opened online at the office of the Assistant Executive Engineer, Transmission Subdivision, Payyanur on the date and time mentioned above.

Originals of all Agreements in stamp paper and other documents, enclosed in a sealed envelope indicating e – tender No. **01/AEE/TSD/PNR/2020-21** shall be submitted to the Assistant Executive Engineer, Transmission Sub-Division, Payyanur before opening the bid.

All bidders participating in the tender should have a valid Digital Signature Certificate availed from an approved Certifying Authority. The tenderer should quote the percentage rate of contract

The contractor shall quote the price excluding GST and considering all other taxes, if any, applicable. The price has to be quoted, after considering the current market rate and after passing on the benefit of Input Tax credit , as per section 171 of the CGST Act 2017. **The bidders don't have GST registration can also participate in the tender. Tender evaluation will be carried out as per the prevailing rules in the KSEB Ltd. The contractor shall specify their registration status with GSTIN , and applicable GST (both rate and amount) separately in contractor details submitted.** If GST details are not furnished, the bid shall be rejected. In case of work contracts or pure labour contracts, the bidder shall quote single GST rate for the work.

Tender Evaluation

1. If the tenderer/ bidder does not include the details of GST separately in the tender/ quotation, the same will be rejected.
2. If all the bidders for a Tender are registered under GST, and uniform GST rate is applicable, Tenderers will be evaluated based on the amount exclusive of GST.
3. Additional claim of GST by a contractor /supplier successful bidder, on account of change in the registration status after the award of work, will not be allowed.

All other terms and conditions existing in KSEBL for similar tenders are applicable to this also.

All the tenderer must have PAN card, and status of contractor under GST has to be specified (Registered) and GST registration details to be furnished.
