3. The tender document consisting of scope of work and other necessary documents can be seen from **website www.eprocure.gov.in** free of cost.
4. Those contractors not registered on the website mentioned above, are required to get registered beforehand.
5. The intending bidder must have valid class-II/III digital signature to submit the bid.
6. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
7. Firm can upload documents in the form of JPG format and PDF format.
8. Copy of experience, GST registration etc. as required shall be scanned and uploaded on the e-tendering website within the period of tender submission.

All the bid documents such as eligibility documents, Registration for GST etc. should be scanned and uploaded in complete form in the view document folder while uploading the Bid on www.eprocure.gov.in. Incomplete bids shall be summarily rejected and no clarification shall be sought thereafter. **Online bid documents submitted by intending bidders shall be opened only of those bidders, whose scanned and uploaded documents are found in order.**
