1.0 NTPC Limited (NTPC) invites online bids on "Single Stage Two Envelope Bidding basis" from eligible bidders for aforesaid package, as per the scope of work briefly mentioned hereinafter.

#### 2.0 BRIEF SCOPE OF WORK

The scope of work includes supply, erection and commissioning of 126KWp Roof top Solar Power Plant at NTPC-Kawas completing the facility covering all the activities and services in respect of all the equipment & works specified and covered under detailed bidding documents. The scope also include Comprehensive Maintenance Contract (AMC) of the project for a period of 5 years after commissioning.

Detailed scope of work has been specified in the bidding documents.

- 3.0 NTPC intends to finance subject Package through Domestic Commercial Borrowings/Own sources.
- 4.0 Detailed Specification, Scope of Work and Terms & Conditions are given in the Bidding Documents, which are available for examination and Sale at our eProcurement Portal (https://eprocurentpc.nic.in/nicgep/app) and as per the following schedule:

No Queries from Bidders, whatsoever, shall be entertained by the Employer beyond the last date of receipt of Queries as specified above.

5.0 All bids must be accompanied by Bid Security for an amount of INR 1,00,000/- (Indian Rupees One Lac only) in the form as stipulated in the Bidding documents. Bid Security shall be submitted in a sealed envelope separately in physical form by the stipulated bid submission closing date and time at the address given below.

ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE BID SECURITY IN A SEPARATE SEALED ENVELOPE SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED.

#### 6.0 QUALIFYING REQUIREMENTS FOR BIDDERS.

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

#### **6.1** Technical Criteria:

The Bidder should have designed, supplied, 'erected/supervised erection' and 'commissioned/supervised commissioning' of SPV based grid connected power plant of at least one plant of 25 KWp or above and cumulative capacity of 100 KWp or above. The reference plant of 25 KWp or above capacity must have been in successful operation for at least six months prior to the date of techno-commercial bid opening.

#### Note:

- 1. The qualifying criteria related to work executed as mentioned in clause 6.1 above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
- 2. In case of orders under execution, the value of work executed till the date of techno-commercial bid opening by the client shall be considered acceptable.
- 3. The reference SPV Based grid connected power plant of 25 KWp or above capacity developed by Bidder for itself or any other client.
- 4. Bidder shall submit certificate of successful completion/operation from the Owner. In case the Bidder has executed the project for its own group company/special purpose vehicle, Bidder shall, in addition, obtain a certificate from DISCOM/power procurement agency for commissioning date.
- 5. Projects executed by Bidder's group company, Holding Company or Subsidiary Company shall not be considered as Bidder's experience for meeting the QR.
- 6. The Bidder shall also be considered qualified, in case the award for the reference works has been received by the Bidder either directly from owner of plant or any other intermediary organization. A certificate from such owner of plant shall be required to be furnished by the bidder along with its techno-commercial bid in support of its claim of meeting requirement stipulated above.
- 7. SPV based Roof-top and ground mounted solar power projects, which are grid connected, shall be considered as Bidder's experience for meeting the QR.

#### **6.2** Financial criteria:

- **6.2.1** The average annual turnover of the Bidder, should not be less than **57.38 Lakh** (**Rupees Fifty-Seven Lakh and Thirty-Eight Thousand only**) during the preceding three (3) completed financial years as on the date of Techno-commercial bid opening.
- **6.2.2** In case the bidder does not satisfy the financial criteria, stipulated at Cl. 6.2.1 above on its own, its holding company would be required to meet the stipulated turnover requirements at Cl. 6.2.1 above, provided that the net worth of such holding company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the holding company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the holding company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- **6.2.3** In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents in substantiation of its qualification.
  - 1. Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of the Holding Company.
  - 2. A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bid documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.
- **6.2.4** In cases where audited results for the last financial year as on the date of technocommercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno-commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

#### NOTES:

- 1. Other income shall not be considered for arriving at annual turnover.
- 2. "Holding company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India.
- 7.0 NTPC shall allow purchase preference, as indicated in the bidding documents, to bids from local suppliers as defined in the bidding documents. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

- 8.0 NTPC reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 9.0 A complete set of Bidding Document may be downloaded by any interested Bidder from <a href="https://eprocurentpc.nic.in/nicgep/app">https://eprocurentpc.nic.in/nicgep/app</a>. Tender fee as mentioned above in the form of a crossed account Payee demand draft in favor of NTPC Ltd., Payable at Kawas is required to be submitted in separately sealed envelope at the address mentioned in the bidding document before stipulated date & time of submission of bid.

- 10.0 Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening. Bidder shall furnish Cost of bidding document, Bid Security and Power of Attorney separately offline as detailed in Bidding Documents by the stipulated bid submission closing date and time at the address given below.
- 11.0 Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
- 12.0 NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
