The petitions of Ultratech Cement Limited, Dankuni Cement Works at Dankuni and Sonar Bangla Cement Works at Raghunathganj, Murshidabad for wheeling of 7.425 MW and 10.00 MW of power by Ultratech Cement Limited from their captive power plant at Bhatapara - Baloda Bazar, Chhattisgarh to their works at Dankuni, West Bengal and Raghunathganj, District: Murshidabad, West Bengal, respectively were heard by the Commission on 29th July, 2021 as scheduled.

During the last hearing held on 17th March, 2021 it was directed by the Commission that -

- a) Ultratech Cement Limited shall submit an affidavit to the Commission satisfying fulfilment of the conditions as specified in rule 3 of the Electricity Rules, 2005 with proper documents/evidences within two weeks from the date of receipt of the order, with a copy to WBSEDCL;
- b) Upon receipt of the affidavit, the next date of hearing will be fixed.

Accordingly, M/s Ultratech Cement Limited have submitted their affidavit along with documents / evidences duly notified in dummy papers with a copy to WBSEDCL.

SUBMISSION DURING HEARING

At the outset, the Commission expressed observation regarding submission of defective affidavit by M/s Ultratech Cement Limited, as the said affidavit was not sworn in a requisite Non-judicial stamp paper required as per provision of the Regulations of the Commission.

The Ld. Advocate of M/s Ultratech Cement Limited submitted that they were not aware that the affidavit has to be sworn in a stamp paper. However, it is a curable defect and they will rectify it.

The Ld. Advocate on behalf of WBSEDCL submitted that while M/s Ultratech Cement Limited will submit the rectified affidavit, they may mention very clearly that the Ultratech Cement Plants at Dankuni and Raghunathganj have twenty six percent ownership of the captive generating plant at Chhattisgarh and 51% of the aggregate electricity generated on annual basis in the captive plant is consumed by captive user. The Ld. Advocate further submitted that they need at least 15 days' time to submit reply, if any, to the rectified affidavit to be submitted by M/s Ultratech Cement Limited.

ORDER

Upon hearing, the Commission directed that -

- M/s Ultratech Cement Limited shall submit their affidavit duly sworn in a Non-judicial stamp paper of requisite value within 7 days from the date of receipt of this order with a copy to WBSEDCL;
- 2) WBSEDCL shall submit their reply, if any, to the affidavit of M/s Ultratech Cement Limited, to the Commission within 14 days from the date of receipt of the affidavit from M/s Ultratech Cement Limited with a copy to the petitioner;
- 3) Upon receipt of the above, the next date of hearing will be fixed.
