IN THE MATTER OF: **Extension of Suo-motu order on Provisional Tariff for MYT 2019-24 for Bajaj Energy Ltd., Lalitpur Power Generation Company Ltd, Rosa Power Supply Company Ltd., UPRVNL and UPJVNL**

ORDER

1. In exercise of powers conferred under Section 181 read with Section 61 of the Electricity Act, 2003 and all other powers enabling in this behalf and Regulation 6 of UPERC (Terms and Conditions of Generation Tariff) Regulation, 2014 dated 16.12.2014, notified vide Notification No. UPERC/Secy/Generation Regulations, 2014/1620:

"(1) The Commission shall carry out truing up exercise along with the tariff petition filed for the next tariff period, with respect to the capital expenditure including additional capital expenditure incurred up to 31.3.2019, as admitted by the Commission after prudence check at the time of truing up.

(2) The generating company shall make an application, as per Appendix II to these regulations, for carrying out truing up exercise in respect of the generating station or any of its units or block of units thereof by 31.10.2019."

2. The Uttar Pradesh Electricity Regulatory Commission (Terms and Conditions of Generation tariff) Regulations, 2019 were subsequently notified on 11.09.2019 vide Notification No. UPERC/Secy/Generation Regulations, 2019/343A for the Control Period 2019-24.



3. Subsequently, due to outbreak of Covid'19 and consequently declaration of country wide lockdown, the Commission vide its Suo-moto order dated 11.12.2020 extended the Provisional Tariff for next six months i.e. during the period 1st November'20 to 30th April'21. Further, due to devastating Covid'19 second wave, impacting functioning of the Commission, the Commission ordered that Provisional Tariff for next six months i.e. for the period 01.05.2021 to 31.10.2021 shall remain as determined by the Commission through various orders respective to these existing Projects under the UPERC (Terms and Conditions of Generation Tariff) Regulation, 2014 subject to adjustment with applicable interest, if any.
4. The Commission has already initiated tariff proceedings in True-up and MYT Petitions filed by various Generating Companies and information / data gaps are communicated to Petitioners. The Petitioners have made various submissions to data gap queries, and these are being examined. MYT of the Control Period 2019-24 shall be decided by the Commission after Public hearing and inviting comments from the stakeholders.
5. Therefore, the Commission orders that Provisional Tariff for the energy supplied by *Bajaj Energy Ltd., Lalitpur Power Generation Company Ltd, Rosa Power Supply Company Ltd., UPRVUNL and UPJVNL* shall remain as determined by the Commission through various orders respective to these existing Projects under the UPERC (Terms and Conditions of Generation Tariff) Regulation, 2014 subject to adjustment with applicable interest, if any, till MYT Petitions of these exiting Projects for Control Period 2019-24 are disposed of or till 31.05.2022, whichever is earlier.
