- Bidders are advised to download bid submission manual from the download bid submission.
- To participate in bidding process bidders, must get digital signature certificate (DSC) as per information technology-2000 bidders can get digital certificate from approved option as well as from “Bidders Manual Kit” on website (jktenders.gov.in) to acquaint vendors.
- The bidders have to submit their bids online in electronic format with digital signature.
- Bids must be accompanied by bid security deposit & cost of tender document as specified in column (3&4) of the above table. Bid security will be in the shape of CDR/FDR pledged in favour of **Executive Engineer, Mechanical Irrigation Division Anantng H.Q Awantipora** and the cost of tender document shall be deposited in the Treasury under MH-0702 Irrigation in favour of **Executive Engineer, Mechanical Irrigation Division Anantng H.Q Awantipora** Name of work to be mentioned on the Treasury Challan / Receipt)
- Earnest Money Deposit CDR shall be deposited only by the 1st lowest bidder after opening of tenders
- Bidders must ensure to upload their bids in **SINGLE COVER** containing documents as under: -
 - i) *Scanned copies of Treasury Challan/Receipt*
 - ii) *Scanned copies of CDR*
 - iii) *Scanned copies of experience certificate related to execution of work of similar type and magnitude carried out by the contractor duly authenticated by not below the rank of Executive Engineer should be supported by Scanned copy of details of existing commitments and ongoing works as per NIT.*
 - iv) *Rates submitted by the bidders in the BOQ.*
 - v) *Scanned copies of acceptance of technical specifications by the firm.*
- Besides above the bidder should also upload the following documents from “**My Document**” area required under “Other Important Documents” (OID)

- i) *Scanned copies of information of other works already executed/tendered for and in hand with the value of work in each case.*
 - ii) *Scanned copy of Valid Registration .*
 - iii) *Scanned copies of PAN, GSTIN Registration Certificate.*
- Bidders must ensure to upload scanned copy of all necessary documents in terms of soft copies with the technical bid and no documents in terms of hard copies shall be entertained. However, in case of any clarification the bidders shall have to produce original documents in support of soft copies if need arises.
 - The original instrument in respect of **Treasury Receipt, EMD** and relevant attested copies of Technical Bid Documents as specified above must be submitted by Lowest Bidder (L1) to **Executive Engineer, Mechanical Irrigation Division AnantangH.QAwantiporab** by hand or by speed/registered post before the allotting of work or as and when demanded. If the bidder fails to produce the same within the prescribed time period, he will be debarred from taking part in tendering process in this division for at least one year.
 - The bidders are advised not to make any change in BOQ (Bill of Quantities). In no case they should attempt to create similar BOQ manually. The BOQ downloaded should be used for filling item rate inclusive of all taxes and it should be saved with the same nomenclature as it contains.
 - No financial bid will be accepted in physical form.
 - The bid shall be deposit in electronic format only on the web site of (jktenders.gov.in) till the end date mentioned in bid submission.
 - The bid(s) shall be opened online on above mentioned date or any other subsequent date in presence of the bidders who may wish to be present.
 - *No claim shall be entertained on account of disruption of internet services being used by bidders and are advised to upload their bids well in advance to avoid any technical snags in last hours.*

TERMS AND CONDITIONS

- 1- The department will not be responsible for delay in online submission due to any reason whatsoever claimed by the bidder.
- 2- The tenders shall remain valid for 180 days only.
- 3- The successful tenderer shall have to arrange, construct and maintain at his own cost necessary walkways, platform, ladders, stairways, water and other facilities of usual and suitable character for all operations of construction and inspection.
- 4- As soon as the contract is fixed with the successful bidder it is mandatory for him to enter into an agreement with the department.. However, non-drawl of agreement will not prevent the contract from being enforced upon him.
- 5- Immediately after the acceptance of bid is communicated to the tenderer through a letter of intent, he shall furnish to the department within 10 days, six copy each of the detailed layout, drawing, sectional drawings etc (if required) , complete with dimensions supported by the comprehensive design calculations at structure for the process of vetting/approval of the department and department design, inspection and quality control, J&K Government, two copies each of the approved drawings shall be returned to the bidder and will become final drawings. Neither partly shall deviate from these final plans and drawings.
- 6- All mechanical / electrical / regulating devices shall be of reputed make as given in BOQ.
- 7- The earnest money shall be forfeited if: -**
 - a) Any bidder withdraws his bid during the period of bid validity or makes any modification in terms and conditions of the bid.
 - b) The Successful contractor fails to execute an agreement within 10 days after fixation of contract.
 - c) The successful bidder fails to start the work within one week from date of fixation of contract.
- 8- The tender opening authority reserves the right to accept/reject any or all bids without assigning any reason thereof.
- 9- In case the bidder quotes rates below estimated cost , the bidder is liable to submit additional security deposit as per the Government rules and regulation in vogue .
- 10- Watch and ward of material supplied for the works shall be exclusively the responsibility of the successful contractor/ bidder and in the event of any loss / theft of the material the same shall be responsibility of the bidder, the cost thereof shall be recovered @ double the allotted rates.

- 11- The successful bidder or his authorized representative/agent and qualified Engineer of the contractor/firm shall have to remain at the site of work to receive the instructions from officer in charge of the work with regard to his execution and maintaining discipline at the site of work and no trespass upon Government or private property.
- 12- Any kind of damage which may occur to any work during the course of execution due to incessant/torrential rains /heavy snowfall/ cyclone/ flood etc. shall be the responsibility of the bidder until the work is finally handed over to the Irrigation & Flood Control Department.
- 13- No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service, without permission of the Government. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government as foresaid before submission of the tender or engagement in the Contractor's Service.
- 14- The taxes etc. shall be deducted from the bidders claim as admissible under rules.
- 15- The date of start of work shall be reckoned within one week from the date of issuance of letter of intent/contract allotment as the case may be.
- 16- Beside the earnest money, security deposit 10% from each payment shall be deducted from all the running bills of contractors. Security money and earnest money shall not bear any interest.
- 17- 90% of the total value of the allotment order shall be paid after execution of the job in full . Balance 10% shall be paid after satisfactory performance of the equipment for a period of 01 year, which may be released only after recommendations from the concerned Asstt Executive Engineer .Store & Transport Sub Division
- 18- The final payment of the work will be made only after successful commissioning and testing etc. If any defect is found, the contractor will be bound to repair/replace the same at his own risk & cost.
- 19- The defective liability period shall be 12 months after the successful commissioning of the structure, and 10% of the contract will remain as deposit money which will be released only after the defects (if any found during the said period) are rectified without any extra cost by the contractor and that no extra claim by the contractor will be acceptable for such rectification
- 20- If the work is suspended by the department (due to any reason) no compensation will be paid to the bidder. However, extension in time limit for completion of the work will be granted for such suspension subject to the confirmation by the competent authority, in case there is no fault of the contractor/firm in such suspension the work.

- 21- Bidder should note that terms and conditions of the contract circulated by the authorities from time to time applicable on the contract even if not incorporated in this tender notice.
- 22- In case of any dispute regarding the work **Chief Engineer Kashmir I&FC Department, Srinagar** shall be the sole **ARBITRATOR**.
- 23- In case of any typographical error, if found in the rates, quantities or units etc. the same shall be corrected and paid as per the rates in vogue under rules
- 24- Any other information can be obtained from the office of the undersigned on any working day during office hours.
- 25- All other terms and conditions will remain same as laid down in PWD form No.25-double.
