- The existing enterprises registered prior to 30th June, 2020 shall continue to be valid only for a period up to the 31.03.2022.
- In the list of documents acceptable for being a MSME, Udyam Registration Certificate has been added.
- It is advised that all the Prospective Bidders shall register and obtain Udyam Registration Certificate. It may be noted that w.e.f. 01.04.2022, Udyam Registration Certificate shall be only valid Certificate to avail the benefits as per Public Procurement Policy.
