- 1. The contractor should issue I-Cards to his workers deployed on regular basis and list of such workers vetted by site Engineer should be submitted to security.
- 2. The supervisor of contractor having photo pas shall bring daily wages workers / casual workers inside premises for work subject to following conditions. He would prepare list of such workers in duplicate. The original copy would be handed over to security at gate and obtain endorsement on duplicate copy and the duplicate copy would remain with the contractor. However departmental staff detailed to supervise his work has to verify the reporting of such workers at site.
- 3. Contractor's personnel including daily wage workers shall be in uniform with proper identification.
