Eligibility and Qualification requirements:

(Ref tender: BNS/PROJECT/2020/SANADAR/SPV POWER PLANT)

The bidders must meet the following minimum qualification criteria:

1. The Bidder should be either OEM or their authorized representative in India. Original Equipment Manufacturers authorization certificate should be submitted if the bid is submitted by Indian authorized representative of OEM.
2. The Bidder in the same name and style should be in the similar business for at least three financial years. In case of change of name of bidder by merger / acquisition / change in status, the bidder has to submit documentary evidences.
3. The Bidder's average financial turnover in the same name and style during each of the last three financial years (i.e. 2018-19, 2019-20, 2020-21) should not be less than INR 600 Lakhs. Balance sheet and income tax return as a documentary evidence shall be provided for the proof of financial turnover.
4. The Bidder in the same name and style shall have successfully executed / completed contracts of similar nature (SPV Power Plant) during the last five years ending last day of the month previous to the month in which bid is opened, either of the following: -
 - a) One contract costing not less than INR 400 Lakhs

OR

 - b) Two contracts each costing not less than INR 320 lakhs

OR

 - c) Three contracts each costing not less than INR 240 Lakhs

Copy of the purchase orders and their Completion certificates for the works mentioned in the qualification criteria shall also be submitted.
5. The bidder should have valid registration under various acts that may be applicable for the contract proposed. This shall include but not limited to income tax, GST, Employee State Insurance, Contract Labour, Provident Fund etc.
6. In addition to the above, the following information / documents should also be submitted along with the bid by the bidder for evaluation / determination of their eligibility:
 - a. Copy of income tax returns for five financial years as mentioned above in original or certified true copies, along with Permanent Account Number (PAN) for income tax purpose.
 - b. Copy of TDS certificate issued by the clients to substantiate the claim for the value of works in the private sector.

7. Even though the Bidder meet the specified criteria, the bid may be disqualified in case the bidder has:

- a) Made untrue or false declaration in the forms, statements and attachments submitted in proof of their qualifications.
- b) Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion or financial failure etc.

Interested bidders can purchase the bidding documents in person between 11:00 - 16:00 hours on any working day with in tender sale period specified above on payment of non refundable tender fees of Rs 5000 + 18 % GST by DD/RTGS (in favour of Banaskantha District Co-operative milk Producers' union Limited payable at Palanpur) or by paying non refundable fees of Rs 5000 + 18% GST in accounts department of Banas dairy and submission of payment receipt.

In case bidder wishes to purchase the bid document through courier/ post they have to submit a DD of Rs 5000 + 18 % GST + Rs 500 towards the courier charges in favour of Banaskantha District Co-operative milk Producers' union Limited payable at Palanpur. 2. Pre bid meeting

The Bidder who will participate should submit their technical deviation form though email by dated 20-07-2022. The discussion in the pre-meeting shall be based on technical deviation form. The pre-bid meeting can also be term as technical bid (Cover I) and shall contain all the technical details except for the price.

3. Submission of bid

This invitation of bids is open to all Bidders who meet the minimum eligibility criteria specified in this bid document.

4. Bid Security/earnest money deposit (EMD)

All bids must be accompanied by bid security (EMD) of Rs. 4 lakhs. The EMD should be in the form specified in the bidding document & incorporated in the technical bid (Cover I). Bids not accompanied with EMD, shall be summarily rejected.

5. Opening of Bids

This is a single stage bid in which Pre-bid meeting shall be arranged for the technical discussion before commercial bidding. All the bidders shall submit the bids in Cover I - Technical bid and Cover II- Price Bid. The technical bid (Cover I) shall contain all the technical details except for the price. Both bids shall be opened on the date and time specified above in the presence of representative of interested bidders. There shall be prebid meeting on 25-07-2022.
