## **ORDER**

The Commission vide Order dated 21.07.2022 observed that the CERC RE Tariff Regulations adopted by the Commission, under Regulation 8(2) mandates the "Consent from beneficiary for procurement of power from renewable energy project at tariff approved by the Commission, in the form of initialled PPA or MOU" and directed the petitioner to file its rejoinder in the matter. PEDA filed its reply dated 28.07.2022 reiterating its earlier submissions. Further, Ld. Counsel of the PEDA submitted that MNRE vide Office Memorandum dated 18.08.2022 has informed that for Feeder Level Solarization under Component-C, State Implementing Agencies can invite bids without waiting for the ceiling tariff. Accordingly, its prayer would survive for component-A only. Ld. Counsel for PSPCL submitted that the said document be placed on the record for submission of its response on the same. PEDA shall submit the copy of memorandum dated
