	<p>Tenderer's will be technically qualified on the basis of submission of following:</p> <ul style="list-style-type: none"> •Requisite EMD •Based on the availability of other credentials indicated below: <p>Tenderers are required to upload copies of following documents -</p> <ol style="list-style-type: none"> a) Copy of relevant pages from Audited Balance Sheets for annual turnover values. b) Copy of PAN (Permanent Account Number) c) GSTIN Number: The party should have valid GSTIN number. Order shall be issued only after provision of GSTIN. d) Constitution of the Firm. In case of proprietary firm, proprietor details to be provided with full name and address. in case of partnership firm, full names and addresses of all partners/directors as per Partnership Deed to be provided. <p>However, mere submission of the relevant information would not entitle the tenderer for technical qualification. The details submitted and the credentials will be verified by the concerned authority. EVALUATION CRITERIA	<ol style="list-style-type: none"> a) Only the Technical Bids of those parties submitting their tenders before due date and time of submission, shall be opened on the due date & time of opening. The tenders will be rejected if requisite EMD instrument is not uploaded on or before the due date/time of submission. b) The offers shall be scrutinized and evaluated based on the qualifying parameters mentioned above, requisite credential certificates uploaded and verification of the credential documents. c) The Price Bid of only those parties shall be opened who comply with the requirements as mentioned above. Prior intimation will be sent to the qualifying parties regarding due date and time of opening of Price Bid. d) After opening the Price Bid, party who has quoted the lowest rate (L1rate) will be considered for award of works pertaining to L1 with or without negotiation as per the policy of the Corporation. e) In case of identical quotes at L1 position, all the L-1 bidders shall be asked to submit
