Subject: Outcome of the Meeting of Board of Directors of Gensol Engineering Limited ("the Company") in accordance with Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations").

With reference to the above captioned subject and in terms of the provisions of Regulation 30 of Listing Regulations, we wish to inform your good office that the Board of Directors of the Company, at their meeting held today i.e., **Friday**, **August 19**, **2022**, have, *inter alia* transacted the following businesses:

- I. Considered and Approved acquisition of majority stake in Gensol Electric Vehicles Private Limited which would further acquire technical and business know-how, patents, trademark and brand name related to electric vehicles from US based company.
- II. Increase and alteration of Authorized Share Capital of the Company from Rs. 12,50,00,000/- (Rupees Twelve Crore and Fifty Lakh Only) divided into 1,25,00,000 (One Crore and Twenty-Five Lakh) Equity Shares of Rs. 10/- each to Rs. 15,00,00,000/- (Fifteen Crore Only) divided into 1,50,00,000 (One Crore and Fifty Lakh) Equity Shares of Rs. 10/- each.

Such increase and alteration in the Authorized Share Capital of the Company will require consequent amendment in the Capital Clause of the Memorandum of Association of the Company, subject to shareholders' approval.

III. Considered and Approved the Issue and allotment of upto 13,51,030 (Thirteen Lakh Fifty-One Thousand Thirty) Equity Shares of face value of Rs. 10/- (Rupees Ten Only) each to persons belonging to Promoter & Promoter Group Category and Non-Promoter Category, on preferential basis, at an issue price of Rs. 1036.25 (Rupees One Thousand Thirty-Six and Twenty-Five Paisa Only) in accordance with provisions of Chapter V of SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended and applicable provisions of Companies Act, 2013 and rules made thereunder aggregating to upto Rs. 1,40,00,04,837.50 for cash, subject to shareholders' approval.
