## ORDER (Date of Hearing – 24.11.2022)

- UPPCL, DVVNL and UP Irrigation and WR Department (referred as Generator)
  entered into tripartite Agreement on 29.01.2018 for banking of solar power.
  Instant Petition were filed by UPPCL and DVVNL for seeking approval of this
  agreement.
- UP Irrigation & WR Department intends to commission 2.5 MW and 3.42 MW canal top captive solar plant at Jakhlaun pump canal at Jakhlaun, Jhansi. UP Irrigation intends to bank this energy and use it for its 750 KW X 5 pumps and

balance power shall be used at Augasi pump house at Samgara, Tehsil Baberu District Banda. It is also sought that use of banked power be allowed at Augasi pump station with applicable wheeling charges.

- 3. The matter was last heard on 28.10.21, wherein UPPCL submitted that they would be filing and affidavit to withdraw the Petition.
- 4. During the proceeding today, Shri. Deepak Raizada, CE-PPA, UPPCL submitted that the Commission has issued the new CRE Regulations, 2019. Accordingly, he requested for withdrawal of the instant Petition.
- 5. Shri. Murad Khan, JE, IWRD submitted that they have no objection to the request of UPPCL.
- 6. After hearing the parties, the Commission allowed withdrawal of the Petition.

These Petitions are dismissed as withdrawn.
