INTERIM ORDER

- 1. The case was taken-up for public hearing, as scheduled on 23.02.2023 in the Court Room of the Commission.
- The learned counsel Ms. Nikita Choukse, appeared for the HPPC/Discoms and reiterated the comments filed by HPPC on the tariff petition filed by M/s. IA Hydro Energy Pvt. Ltd.

3. Shri. S.K. Goyal, CEO along with Sh. Vikas Kumar, Advocate, appeared for the

petitioner i.e. M/s IA Hydro Energy Pvt. Ltd.

a) In compliance to the directions issued by the Commission in its Interim Order

dated 09.02.2023, the counsel informed that public notice was issued in two newspapers and accordingly, they have received comment of only one

stakeholder, i.e. Sh. V K Jain.

b) The counsel laid emphasis on the order issued by Chhatisgarh ERC in this matter

and stated that Chhatisgarh ERC's has allowed Rs 604.27 crore for capital cost,

and determined tariff @ 5.98 per Kwh in their order. A copy of the said order was

placed on record.

c) He further requested that capital cost may be approved on the same basis as the

cost was approved by Chhatisgarh ERC and other components of the cost may

be approved as per the relevant HERC Regulations.

4. The counsel for the respondent submitted that the Hon'ble Commission may consider

the written reply filed by them read with the observations of the Hon'ble Commission

while according "source approval" to the petitioner's 36 MW power project.

5. The counsel for the petitioner also suggested that further hearing in the matter may

not be necessary and sought some time to file their written submissions in response

to the comments filed by HPPC. The counsel for the respondent also sought time to

file replication to the written submissions of the petitioner.

6. Upon hearing the parties, the Commission observes that the Hon'ble Supreme Court

has remanded the matter back to this Commission for passing Tariff Order, within two

months from 24.01.2023. Hence, keeping in view the timeline for issuing the tariff

order in the present matter, the Commission allows 5 days' time to the petitioner to

file the written submissions with an advance copy to the petitioner. And further allows

3 days' time to the respondent to file their response after the written submissions

have been filed by the petitioner.

7. The order is reserved.
