### **PUBLIC NOTICE**

**Inviting comments on draft Maharashtra Electricity Regulatory Commission (Specific Conditions of Distribution License applicable to AEML SEEPZ Ltd. for multi-product SEZ at SEEPZ SEZ, Mumbai) Regulations, 2023**

M/s. AEML SEEPZ Ltd. (ASL) has been approved by the Ministry of Commerce and Industry, Government of India, as a co-developer for the SEEPZ SEZ in Mumbai for the area admeasuring 103 acres leased by MIDC vide the Lease Deeds dated 20 January 1975 and 28 June 2005 respectively.

In accordance with section 14 (b) of Electricity Act, 2003 (EA) read with sub-section (1) of section 4 of Special Economic Zones Act, 2005 (SEZ Act), ASL is a deemed distribution licensee to operate and maintain a distribution system for supplying electricity to the consumers in aforesaid SEZ area. The Commission vide Order dated 6 June 2022 in Case No. 2 of 2022 has confirmed the deemed distribution licensee status of ASL.

The Commission under Section 16 of the EA has prepared the draft Maharashtra Electricity Regulatory Commission (Specific Conditions of Distribution License applicable to AEML SEEPZ Ltd. for multi-product SEZ at SEEPZ SEZ, Mumbai) Regulations, 2023.
