“2.12. With the above observations, following order is issued:

1. While appreciating the petitioner for the initiative taken in Energy Storage System, the Commission is pleased to grant permission to the petitioner to set up 4 MWhr Battery Energy Storage System powered by their allied 2 MW Solar Power Plant in same site, first of its kind in the State.

2. The petitioner is permitted to adjust the stored energy exported in to the grid in the respective slots/blocks including peak hour slot.

3. All charges applicable and other related terms and conditions are as per the regulations and orders of the Commission in force from time to time.

4. The current harmonics shall be controlled and maintained by the petitioner as stipulated in the Supply Code of the Commission, as amended.

5. The technical, commercial, operation and maintenance conditions, metering, protection and billing mechanism, other related matters etc. shall be communicated comprehensively to the petitioner by the Licensee in clear terms. All such conditions shall be part of the agreement to be executed bilaterally between the petitioner and licensee. Ordered accordingly”.

2.6. Consolidating the above, the following orders are issued:

(1) *The structure of working procedure for implementation of Green Energy Tariff and issuance of Green Energy Certificate by the TANGEDCO is approved in principle subject to the conditions stated supra.*

(2) *The licensee shall encourage the consumers in letter and spirit who opt to procure Green power. The licensee shall designate consumers who opt to procure green power to meet 100% of their consumption as "Green Consumers" in recognition of their noble contribution to society, by mitigating carbon emission.*

(3) *TANGEDCO shall provide the facility of requesting for Green Power Tariff through its Web Portal within a month from the date of this order. However, the applications on hand and applications likely to be received before implementation of on line web portal processing shall be processed manually and disposed without delay, preferably within a fortnight.*

(4) *The Green Tariff and its implementation shall take effect from the date of this order.*
