**ORDER**  
**(Date of Hearing 18.05.2023)**

1. The Petitioner, UPPCL, has filed the instant Petition seeking approval of Supplementary PPA dated 03.01.2023 executed between UPPCL and MSL to reduce the installed capacity of the existing PPA dated 16.12.2006.
2. The Petitioner has made the following prayer(s):
  - a) Admit the Petition.



- b) Accord approval to Supplementary PPA dated 03.01.2023, entered into between M/s Mawana Sugars Ltd. and U.P. Power Corporation Limited to reduce the installed capacity from 54.5 MW (27.4 MW + 27.1 MW) to 50.5 MW (23.4 MW + 27.1 MW).
- c) issue any other order or direction as it may deemed fit in the facts and circumstances stated in the Petition.

The matter came up for hearing today.

3. During the proceedings, Sh. Deepak Raizada on behalf of UPPCL submitted that present Petition has been filed for approval of the Supplementary PPA dated 03.01.2023 regarding change in the installed capacity of the Respondent's project from 54.5 MW to 50.5 MW under the PPA dated 16.12.2006.
4. The Commission enquired UPPCL, whether there is any change in the quantum and / or tariff that as agreed in the existing PPA dated 16.12.2006. Sh. Raizada responded that there is no change in either but only the installed capacity of Plant is being reduced.
5. **The Commission finds no locus of UPPCL seeking approval of the Commission under section 86(1)(b) of the Electricity Act 2003, as there is no change in either power procurement quantum or tariff of the existing PPA.**

Accordingly, the Petition is not admitted and disposed of.
