1. Bid documents will be available in web site <http://tntenders.gov.in> from **10.07.2023 to 24.07.2023** upto 3.00 P.M for online bidding. The bidders must possess Digital Signature Certificate and submission of bids through online in the above web site and not accepted any other mode.
2. Bids must be submitted by the bidders through online from **14.07.2023 to 24.07.2023**, upto 3.00 (as per web site digital clock). Bids will be received online only and shall be opened at 4.00 P.M on **25.07.2023** (as per web site digital clock) at first floor, CMDA Office building, Tower-3, 'E' Road, Koyambedu, Chennai 600 107, by the tender committee of CMDA. If the date of opening happens to be a public holiday, the bids will be opened on the next working day at the same time and venue.
3. Earnest Money Deposit (EMD) shall be paid only online through the <http://tntenders.gov.in>. The EMD is exempted from payment for MSME / NSIC registered contractors, which bidders can upload their MSME and NSIC certificate as a PDF.
4. The intending bidder must have valid only class-III digital signature with signing certificate to submit the bid.
5. Subsequent corrigendum/addendum, if any issued will only be available in web site indicated above.

6. On opening date, the contractor can login and see the bid opening process from anywhere, after opening of bids.
7. On behalf of CMDA, the Superintending Engineer, Circle-II, CMDA, Chennai-107, reserves the right to reject any or all the tenders received without assigning any reason thereof and drop the proposal.

ELIGIBILITY CRITERIA

- 1) The TENDERER should be a well-established, reputed/registered contractor in any of State/Central Govt. Departments/Govt. undertakings / Boards under Class-I with Monetary limit above Rs. 75.00 lakhs with up to date renewal and registered as a legal entity in India for a minimum period of ten years, and having experience of minimum seven years in the capacity of Supply, Installation, Commissioning and 5 years Comprehensive maintenance of Grid connected Solar Photovoltaic (SPV) power plant for cumulative capacity of 250KWp plants.
- 2) The tenderer should have satisfactorily completed similar nature of works with at least one single work to a value of **Rs.81.00 lakhs** (under single agreement) in any one of the preceding seven years (i.e. From April 2016 to March 2023).
- 3) The applicant should furnish the Annual turnover of **Rs.2.43 crores** in any one of the preceding five years ending March 2023.
- 4) The tenderer should furnish the latest Income Tax Return/Saral, GST registration Certificate, Registration as a contractor certificate, Performance certificate and Annual Turnover and also to furnish all documentary evidence for Pre-qualification as per technical bid in order to be eligible to participate in this tender.
- 5) **Joint venture is allowed to participate in the tender. The annual turnover of Rs.2.43 crores and experience for Rs.81.00 Lakhs will be considered either in Single or jointly amongst the Lead and Co-applicant.**
- 6) **Experience certificate should be deposited in the tender box at o/o The SE-II, Construction Wing, first floor, Chennai Metropolitan Development Authority office building, 'A' Block, 'E' Road, Koyambedu, Chennai – 600107 before the closing date of bid i.e. on 24.07.2023 upto 3.00pm**
- 7) The tenderer must not have been debarred or black listed by any of the Central / State Government Departments / Government Undertakings.
- 8) The Experience / Performance certificate submitted by the tenderer under Sub-Contract will not be considered.
- 9) If the date of opening of tenders happens to be a public holiday, tenders will be opened on the next working day at the same venue and time.
- 10) All other conditions can be seen in the bidding documents.
