Explanatory memorandum on "Rajasthan Electricity Regulatory Commission (Service) (Seventh Amendment) Regulations, 2023.

Explanatory memorandum

- (1) The Commission has framed the Rajasthan Electricity Regulatory Commission (Service) Regulations, 2005 with approval of the State Government.
- (2) State Government has implemented the Old Pension Scheme in Public undertaking/Autonomous body/University etc. where CPF/EPF/NPS or no scheme was applicable vide order no. F.13 (12) Fin. (Rules)/2021 Dt. 20.04.2023 (Pension 02/2023 & Pension 03/2023).
- (3) Considering the above, a proposal was sent to the State Government by the Commission for implement the Old Pension Scheme in respect of absorbed employees and retired (CPF) employee in RERC. Accordingly, State Government has accorded approval vide its letter dated 02.06.2023 for implementing the Old Pension Scheme in RERC for which appropriate amendment in the Service Regulations is required.
- (4) Accordingly, the Draft RERC (Service) (Seventh Amendment) Regulations, 2023 have been prepared and as per the requirement of section 181 (3) of the Electricity Act, 2003, Comments/suggestions are invited from the interested persons before finalizing them.

In exercise of the powers conferred on it by Section 91 read with Section-181 of the Electricity Act, 2003, (No.36 of 2003), the Rajasthan Electricity Regulatory Commission after previous publication hereby makes the following regulations, namely:-

GENERAL

1. Short Title, Commencement and Scope:

1. These Regulations shall be called the "Rajasthan Electricity Regulatory Commission (Service) (Seventh Amendment) Regulations, 2023.
2. These regulations shall come into force from the date of their publication in official Gazette.

2. Amendment in 'Regulation 14(1) of Regulation 35 in RERC (Service) Regulations, 2005:

The following words in existing Regulation 14(1) shall be replaced as under:

Regulation	Existing	Proposed
14 (1)"In all cases of absorption, the absorbed employees shall be appointed in RERC and they shall be eligible for the benefits of New Contributory Pension Scheme (NPS) only and shall not be entitled for any other retirement benefits like pension, gratuity, leave encashment etc. even though they were eligible for pensionary benefits in their parent department. However, such persons shall be governed by the provisions of NPS""In all cases of absorption, the absorbed employees shall be appointed in RERC and they shall be eligible for the benefits of old Pension Scheme as amended by State Government from time to time"
