

INVITATION TO PRE-TENDER MEET FOR SOLAR SYSTEM (NRL JOB)

Introduction:

M/s Numaligarh Refinery Limited (NRL) is a Government of India Enterprise operates a 3.0 MMTPA Refinery at Numaligarh in the District of Golaghat, Assam since the year 2000. NRL is now in the process of executing a major expansion project of capacity augmentation from present 3.0 MMTPA to 9.0 MMTPA.

NRL is setting up 6 MMTPA Crude Oil Import terminal (COIT) at Paradip. The required additional quantity of crude oil is planned to be imported through IOCL Crude oil Terminal to NRL's Crude Oil Import terminal (COIT) in Odisha. A 50 inch size inter connecting pipeline shall be laid from IOCL COT to NRL's COIT Paradip. A 26 inch size cross country pipeline of around 1630 km shall be laid from NRL's COIT to Numaligarh refinery for transporting 8 MMTPA of imported crude oil.

The above-mentioned pipelines also include Despatch Terminal (DT) at existing terminal of IOCL refinery (IOCL-Paradip) & Receipt Terminal (RT) at NRL COIT Paradip for 50" pipeline and DT at NRL COIT Paradip, four (4) nos. Intermediate Pigging Station (IPS), three (3) nos. Intermediate Pigging cum Pumping Station (IPPS) & RT at Numaligarh for 26" pipeline.

Augmentation of NRL's Siliguri Marketing terminal for 5.5 MMTPA is also being carried out as a part of this project by setting up new product tankages and pumping facilities along with augmentation of Rail and Road Gantry at Siliguri.

Design, detail engineering, manufacture, procurement of material and bought out components, assembly at shop, inspection, testing at manufacturer's works, packing, delivery, installation, testing & commissioning at Site of following Solar Photo Voltaic Power System:
