Bidders willing to take part in the process of e-tendering followed by e-reverse auction are required to obtain Digital Signature Certificate (DSC) in the name of person who will sign the tender, from any authorized Certifying Authority (CA) under CCA, Govt. of India (viz. n Code Solution, Safescrypt, e-Mudhra etc).

Tenders are to be submitted online and intending bidders are to download the tender documents from the website stated above, directly with the help of the e-Token provided. This is the only mode of collection of tender documents. Details of submission procedure are given in RfP.

**Terms & conditions of the Tender Notice :**

1. Each Bidder requires to submit Tender Fee (non refundable) i.e. Rs. 24,000/- (Rupees Twenty four thousand only), along with applicable GST, in the form of Demand Draft (DD) / Banker's Cheque (BC) on any Scheduled Bank approved by Reserve Bank of India drawn in favour of "West Bengal State Electricity Distribution Company Limited" payable at Kolkata. Cost of Tender/Tender Fee shall be submitted per bid basis.
2. All the Bidders would be able to participate in the e-Bidding events on making payment of the requisite fees of Rupees 500 per MW per requisition for the total capacity sought by the Utility for that particular requisition for which the bidder is willing to bid, to PFCL. The requisite fee plus applicable taxes shall be deposited through the portal by e-Payment Gateway provided by MSTC Ltd. After the completion of the bidding process, only successful Bidder(s) will have to pay these charges for the quantum allocated to each bidder. The balance amount will be refunded by PFCL within seven (7) working days without any interest. The fee deposited by non Selected Bidder(s) will also be refunded by PFCL within seven (7) working days of completion of the event without any interest.
3. Earnest Money Deposit shall be submitted individually along with the tender fees.
4. If the offer is submitted without or inadequate Earnest Money, the bid will not be opened. In case of incomplete offer, the tender will be liable for rejection and Earnest Money Deposit will be forfeited.
