Subject: Amendments in the New Solar Power Scheme (for PVTG Habitations/Villages) under PM JANMAN

This refers to the Implementation Guidelines of the New Solar Power Scheme (for PVTG Habitations/Villages) under PM JANMAN issued vide Order of even number dated 04.01.2024. Based on requests from state implementing agencies to include the electrification of Households (HHs) under the scheme by installation of solar mini-grids through CAPEX mode, the scheme Implementation Guidelines are amended as follows with immediate effect:
