- The Report of the Committee has been further discussed in the Ministry and the following is hereby clarified:
  - a. These guidelines issued by the Ministry will only be applicable when there is a large component of Civil work is involved in R&M works of operational Hydro Plants.
  - b. e-Reverse Auction (e-RA) methodology may henceforth be adopted for all future R&M works of Hydro Plants. Only exception could be only those cases where the present R&M works are already under process for tendering.
