**Note:**

- The PV Modules are warranted for output wattage, with not less than 90% at the end of 10 years and 80% at the end of 25 years. The entire system is warranted for 5 years. Required spares for trouble free operation during the warrantee period shall be provided along with the system A detailed O&M manual should be provided with the system.

- After-sales services: After sales services for warranty claim and system repair/maintenance should be provided to the customer. Remote support to be provided within 24 hours of registering the complaint with service team. On-site support should be provided within 48 hours if there is a system breakdown or malfunction during the warranty period.
- The PV modules are mounted on metallic structures of adequate strength and appropriate design, which can withstand load of modules and high wind velocities up to 150 km per hour. The support structure used is hot dip galvanized iron with minimum 80-micron thickness. The PV system can be installed upon the mounting structure at tilt angle as per latitude or as per the requirement of the system. The PV system shall be mounted over the cold storage body to reduce direct solar radiation over cold storage and to maximize space utilization.

### 3.Evaluation:

Prior to evaluation of Proposals, the BHDS will determine whether each Proposal is responsive to the requirements of the RfP. A Proposal shall be considered responsive only if:

- a) It is received in the specified format.
- b) It is received by the due date including any extension thereof.
- c) It contains all the information (complete in all respects) as requested in the RfP.
- d) It does not contain any conditions
- e) It has paid Rs. 500,000/- (Rupees five Lakh Only) as Earnest Money Deposit (EMD) and tender fee of Rs. 5,000/- (Rupees five thousand Only) through online mode (NEFT/RTGS)
- f) All pdf documents must be named clearly as per the list given in the table, without proper naming of the documents, tender won't be considered.

The proposal not found responsive to the requirements of the RFP, shall be rejected.

**3.1 Technical Evaluation: The Technical Proposals will be opened first** and will be evaluated by the evaluation committee constituted at the society. Evaluation of the technical proposal shall be carried out by a committee constituted by the Society, which shall look into Minimum Eligibility criteria and Terms & conditions for empanelment. **Only those bidders qualifying through the Technical Bid will be considered for financial evaluation.**

**3.2 Financial Evaluation:** At the second stage, **Financial Proposal of only technically acceptable agencies will be opened**, for further evaluation. **Price for solar cold room will be discovered on the basis of L1-Least Cost Based Selection (LCBS).**

**3.2.a L1 would be considered as the final cost for Design, Supply, Testing, Installation, Commissioning and Maintenance of 10 MT Solar Cold Storage units in various districts of Bihar.** The evaluation committee may negotiate with the price of L1 with technically qualified agencies if required in the interest of the farmers. Negotiated price after approval of competent authority will be final and applicable to the whole State of Bihar.

**3.2.b** Agencies who agreed to work on L1 or final negotiated price by the evaluation committee and approved by competent authority will be empaneled with the BHDS.

**3.2.c** BHDS has all rights to distribute work among empaneled agencies according to what is the best in the farmers' interest.

### 4. BHDS rights:

- I. The Bidders participating in the tender will invariably be accepting all the terms and conditions of the tender. Non-compliance to any terms and conditions may cause rejection of the bid.

- II. In case, any confusion/dispute occur due to different interpretation of the statement mentioned in the tender document, the decision of the Mission Director, BHDS shall be final and binding upon all concerned parties.
- III. BHDS reserves the right to increase or decrease the quantity, negotiate, accept, distribute the order among two or more agencies or reject any or all the proposal without assigning any reason thereof.
- IV. The evaluation committee may negotiate with the price of L1, if needed in the interest of farmers. The negotiated price after approval of competent authority will be final and applicable to the whole State of Bihar under mentioned schemes.
- V. Evaluation will be done according to the terms and conditions cited in proposal documents under the governance of BFR, 2005.
- VI. Notwithstanding anything contained in the RFP, Mission Director, BHDS, Patna, reserve the right to accept or reject any proposal and annul the selection process and reject all proposals at any time without any liability or any obligation for such acceptance, rejection or annulment and without assigning any reasons thereof.
- VII. The Director Horticulture, Bihar, Patna also reserves the right to reject any or all proposals if:
- VIII. At any time, a material misrepresentation is made or uncovered: or, the bidders do not provide, within the specified time, the supplemental information/any additional information it may find necessary or require clarifying, supplement or authenticate the Bid sought by Director Horticulture, Bihar, Patna. Any request for clarification (s) and all clarification (s) on response thereto shall be in writing.
- IX. **For any query/ confusion related to the tender document must be asked in the pre-bid meeting.** The pre-bid document proceeding will be the part of the tender document. Any query/ concern raised after the pre-bid query date will not be entertained.

#### 5. General terms and conditions for empanelment in BHDS: -

- i. For Design, Supply, Testing, Installation, Commissioning and Maintenance of 10 MT Solar Cold Storage units, beneficiaries will select the empaneled agency as per their choice.
- ii. Empanelment fee will be Rs. 25,000/- for two years which will be non- refundable. It would be essential only for those technically qualified agencies who agreed to be empaneled with BHDS.
- iii. Proposal should be submitted only through online e-tender on website: <https://eproc2.bihar.gov.in>
- iv. Proposal submitted without relevant papers/documents will be rejected.
- v. Telephone No./Mobile No./Email and Full Address of the applicant must be mentioned in proposer Information sheet (Annexure II)
- vi. Micro cool solar chamber shall have to be established at the premises of scheme beneficiaries.
- vii. No charges such as Packing, Forwarding, Freight, Insurance, Loading and Unloading, Clearance etc. will be given to empaneled agency for supplying **solar cold room**.
- viii. In case of any disagreement or dispute arises, both parties shall make every effort to resolve the issues amicably by direct negotiation, If issue still persists, shall be settled under the Court of Law within its jurisdiction at Patna.
- ix. The agencies shall have the full responsibility to timely deliver, Design, Supply, Testing, Installation, Commissioning and Maintenance of 10 MT Solar Cold Storage units to beneficiaries of the schemes. In this regard:
  - Performance security deposit if any to be required, can be forfeited in case of non-performance of the contract and if time limits indicated in the work order are exceeded.



- x. Solar Cold room should be as per the quality specifications mentioned in the proposal documents. Failure to supply as per the quality specifications shall result in forfeiture of EMD, blacklisting and legal action against the agencies.
- xi. The BHDS is free to evolve strong punitive measure against erring agencies to safeguard the interests of farmers in order to ensure proper utilization of public funds.
- xii. The Technical Proposals shall consist of all technical details
- xiii. Financial Proposal will be quoted in figures as well as in words. In case of any ambiguity in amount quoted in words will be considered final. Any correction of entries and over writing in entries may be rejected without any prejudice.
- xiv. EMD and document costs will be the part of Technical Proposal only.
- xv. Tender document cost of INR 5000/-(five thousand) and EMD of INR 5 Lakh through online mode NEFT/RTGS needs to be submitted on or before the opening of technical bids. Bid without tender documents cost and EMD will not be considered.
- xvi. EMD of the technically unsuccessful bidders will be refunded after the rejection of their Proposal and will be retained of the technically successful proposers till the submission of security deposit.
- xvii. The Technical Proposal along with all required documents for technical qualification should be uploaded/submitted through online e-tender on website <https://eproc2.bihar.gov.in>.
- xviii. Financial proposal should also be uploaded through online e-tender on website <https://eproc2.bihar.gov.in> in the prescribed format given on eproc2.
- xix. Price proposed in financial proposal must be inclusive of all taxes and freight for destination etc. Financial Proposal will be quoted in figures as well as in words. In case of any ambiguity in figure amount quoted in words will be considered. The price quoted must be with respect to desired technical specification mentioned in proposal documents. In financial proposal stock availability and capacity to supply must be mentioned.
- xx. Conditional proposal will not be accepted.
- xxi. No claim will be entertained afterwards for any increase in market price or otherwise.
- xxii. Participation for the empanelment process will automatically imply the acceptance, on all the terms and conditions of this notice for empanelment.
- xxiii. The uniform price fixed for the abovementioned its will be valid for three financial year only.
- xxiv. **Performance Security:** The successful agency should have to deposit an amount of 5% (incl. GST) of every work order given in the form of Bank Draft/Bank Guarantee (Issued by nationalized bank only) in favor of the Mission Director, Bihar Horticulture Development Society payable at Patna, Bihar. The security amount shall be forfeited if the party/firm/company/organization fails to provide services. Performance security shall be returned to the agency after one year of the successful operation of the installed unit.

**xxv. Mode of Payment:**

There is provision of 50% subsidy on installation of 10 MT solar cold room i.e. 50% will be borne by the farmers and 50% of total cost will be borne by the directorate. **It is credit linked bank ended subsidy scheme i.e. bank loan is required to avail the scheme.**
