**RAJASTHAN STATE ELECTRICITY REGULATORY COMMISSION**

**Notification (DRAFT)**

**July xx, 2024**

**No. RERC/Secy./Reg./ xxx** - In exercise of powers conferred under Section 181 read with Sections 61, 66, 86(1)(e) of the Electricity Act, 2003 (Act 36 of 2003) and all other provisions enabling it in this behalf, the Rajasthan Electricity Regulatory Commission after previous publication, hereby makes the following Regulations for Grid Interactive Distributed Renewable Energy Generating Systems:

**1. Short title, commencement and extent of application:**

- (1) These Regulations will be called the Rajasthan Electricity Regulatory Commission (Grid Interactive Distributed Renewable Energy Generating Systems) (Second Amendment) Regulations, 2024.
- (2) These Regulations shall come into force from the date of their publication in the Official Gazette.

**2 Amendment in Regulation 12:**

A new Third Proviso shall be added below the existing Second Proviso to the sub-regulation 12.6.1(a) of the main sub regulation 12.6 as under:

*“Provided also that such Educational Institutions, recognized by Gol/ GoR, which have opted for Net-Metering arrangement, may opt Net Billing for a period of any two months during a financial year, for which they have to intimate the distribution licensee before the commencement of such period.”*

**3 Amendments in Regulation 8:**

- (1) The existing sub regulation 8.8 shall be substituted with the following:

*“For installation of Renewable Energy Generating systems, the technical feasibility study shall be completed within a period of fifteen days and the outcome of the study shall be intimated to the applicant, failing which it shall be presumed that the proposal is technically feasible.*

*Provided that the applications for Renewable Energy Generating systems upto 10 kW capacity complete in all respects shall be deemed to have been accepted without requiring technical feasibility study and any commensurate*

*enhancement of the sanctioned load of the consumer, as may be required, shall be carried out by the Distribution Licensee.”*

- (2) The existing sub regulation 8.12 shall be substituted with the following:

*“After installation of Renewable Energy Generating system, the consumer shall submit the installation certificate to the Distribution Licensee and such Distribution Licensee shall complete signing of connection agreement, installation of meter and successful commissioning of the Renewable Energy Generating system within fifteen days from the date of submission of the installation certificate. Formats of contract agreement and installation certificate shall be placed on web-portal of the Distribution Licensee.”*

### **Draft Rajasthan Electricity Regulatory Commission (Grid Interactive Distributed Renewable Energy Generating Systems) (Second Amendment) Regulations, 2024.**

#### **Explanatory Memorandum**

1. The Commission, in exercise of powers conferred under Section 181 read with Sections 61, 66, 86(1)(e) of the Electricity Act, 2003 (Act 36 of 2003) Commission has framed the Rajasthan Electricity Regulatory Commission (Grid Interactive Distributed Renewable Energy Generating Systems) Regulations, 2021 (hereinafter 'RERC DREGS Regulations 2021').
2. The above Regulations, inter-alia, are applicable to:
  - (a) Net Metering arrangements;
  - (b) Net Billing arrangements;
  - (c) Grid Interactive Distributed Renewable Energy generating systems connected behind the meter and operating in parallel with Distribution Licensees' grid and who have not opted either for Net Metering arrangement or Net Billing arrangement:
3. It is observed that Educational Institutions remain closed during vacations, which are predetermined due to which they are not able to consume power from the RE plant installed by them and are not able to use the net billing mechanism even though such mechanism is specified in the Regulations.
4. In order to address the above situation and to balance the interest of both such an Educational Institution as well as the Discoms, Commission has proposed the Amendment in the RERC DREGS Regulations 2021.
5. Further, Commission has also issued suo-motu order on 31.05.2024 wherein the several provisions of the Electricity (Right of Consumers) Amendment Rules 2024 issued by the Central Govt on 22.02.2024 have

been adopted. Accordingly, appropriate Amendments to incorporate these provisions have been proposed in the RERC DREGS Regulations 2021.

6. Comments/ suggestions are invited from the interested persons on the proposed Amendment Regulations.
