and AIVPL

1. The State-Owned utilities and other Distribution Licensees of the State filed the Tariff Petitions for truing up of FY 2022-23, Approval of ARR and Determination of Tariff for FY 2024-25. All these utilities filed their petitions along with Annual Accounts on the principles and methodology prescribed under the GERC Multi-Year Tariff (MYT) Regulations, 2016 as directed by the Commission.
2. These petitions were registered as Dakshin Gujarat Vij Company Ltd. (Petition No. 2318/2024), Madhya Gujarat Vij Company Ltd. (Petition No. 2319/2024),

Paschim Gujarat Vij Company Ltd. (Petition No. 2320/2022), Uttar Gujarat Vij Company Ltd. (Petition No. 2321/2024), Torrent Power Ltd. – Generation (APP) (Petition No. 2322/2024), Torrent Power Limited - Distribution (Ahmedabad) (Petition No. 2323/2024), Torrent Power Limited - Distribution (Surat) (Petition No. 2324/2024) and Torrent Power Limited - Distribution (Dahej) (Petition No. 2325/2024), MPSEZ Utilities Ltd. (Petition No. 2326/2024), GIFT Power Company Limited (Petition No. 2327/2024) and Aspenpark Infra Vadodara Pvt. Ltd. (Petition No. 2328/2024) in accordance with the Electricity Act, 2003 and the relevant Regulations and the Commission proceeded with the Tariff Orders.

3. The Commission determined the tariff and issued all the afore-said Tariff orders on these petitions on 1<sup>st</sup> June, 2024. The Commission has also approved Electricity Tariff Rates for retail consumers, which has been come into force on consumption effective from 1<sup>st</sup> June 2024.
4. Subsequently, the Commission has notified the GERC (Electricity Supply Code and Related Matters) (Fourth Amendment) Regulations, 2024 as Notification No. 14 of 2024, with following amendment ;

Clause 3.2 of the Principal Regulations shall be substituted as under:

“3.2 The rated voltage of the AC supply should be as follows:

Category	System of Supply
For all installations up to and inclusive of 6 kW of Connected Load, subject to motive power load other than irrigation pump not exceeding 2 HP in the aggregate.	230 V- Single Phase
For all installations exceeding 6 kW of Connected Load and up to 100 kVA/kW of Contracted Demand / up to 150 kVA/kW of Contracted Demand if opted by the applicant / consumer.	400 V - Three Phase
For all installation with Contract Demand exceeding 100 / 150 kVA/kW and up to 4000 kVA/kW. However, for the existing 22 kV consumer, the	11 kV and 22 kV - Three Phase

Category	System of Supply
Contact Demand limit shall be extended up to 8000 kVA/kW subject to undertaking from consumer for reverting back to 4000 kVA/kW limit in case of change of system to 11 kV under system conversion scheme.	
All installation with Contract Demand exceeding 4000 kVA/kW.	At 33 kV and above-Three Phase

5. With this afore-said modifications, the Tariff Schedule for FY 2024-25 of the Distribution licensees, which has been issued on Tariff Orders dtd. 1<sup>st</sup> June, 2024 needs to be modified for applicability of tariff for LT consumers.
6. Therefore, relevant Paras of the Tariff Schedule attached to the Tariff Orders dtd. 01.06.2024 in the matter of Truing up of FY 2022-23 and Determination of Tariff for FY 2024-25 in Case Nos. 2318/2024, 2319/2024, 2320/2024, 2321/2024, 2323/2024, 2324/2024, 2325/2024, 2326/2024, 2327/2024 & 2328/2024 respectively is required. Accordingly, a Corrigendum draft Order in Case Nos. 2318/2024, 2319/2024, 2320/2024, 2321/2024, 2323/2024, 2324/2024, 2325/2024, 2326/2024, 2327/2024 & 2328/2024, undergoes following amendments;

<b><u>LT Tariff Category:</u></b> For all installations up to 100 kVA/kW of Contracted Demand.	<b><u>LT Tariff Category:</u></b> For all installations up to 100 kVA/kW of Contracted Demand / up to 150 kVA/kW of Contracted Demand if opted by the applicant / consumer.

7. Other terms and conditions of the Tariff Orders dtd. 01.06.2024 for DGVCL, MGVCL, PGVCL, UGVCL, TPL-D(A), TPL-D(S), TPL-D(Dahej), MUL, GIFT PCL & AIVPL remain unchanged.

8. This alteration/addendum shall come into effect from the date of notification of the GERC (Electricity Supply Code and Related Matters) (Fourth Amendment) Regulations, 2024 numbered as Notification No. 14 of 2024.
9. We order accordingly.
