1.1 The 1352 MW capacity will be installed through 102 Nos. Solar power projects in four districts of the State of Maharashtra.

The above projects shall be divided in four groups which is detailed as under:

- **Group-1** = All 22 Projects under Nashik District + 3 Projects of Ahmednagar District
- **Group-2** = All 9 Projects under Pune District + 16 Projects of Ahmednagar District
- **Group-3** = 26 Projects under Solapur District
- **Group-4** = 26 Projects under Solapur District

The selection of bidder for each group is detailed at section -3 of the bid document.

Note: Preference to MSME/SSI registered with MSME/National Small Industries Corporation (NSIC)/Designated Agency/Startups as recognized by DIPP will be governed by the regulation(s) of the Government of India issued from time to time. Bidders are required to submit a copy of valid MSME/NSIC Certificate/Certificate of recognition as start up from DIPP/relevant certificate along with their bids in accordance with the procedure stipulated in the bid documents in a separate envelope at the time of submission of bid as per provision of NIT. Non-submission of valid certificate along with the bid may lead to denial of exemption/ preference sought / allowed and such bids shall be treated as bids with non-submission of required EMD and Cost of bid document.

1.2 Procedure for selection of successful bidder

The procedure for selection of successful bidder shall be as Clause 3.3 of Section-3.

1.3 Procedure/Requirements For E-Tendering

- b) Bidders shall be required to arrange all resources, including Digital Signature and Internet Connections at their own cost, for participating in online tenders/ bids at the portal.
- c) All the bidders are requested to get themselves registered well in advance and no extra time will be considered for the delay in on-line Vendor Registration, if any. In case bidder waits till the last moment for uploading bids, and if any technical problem is encountered at that time and the bid closing time may elapses, SGEL shall not be responsible in any manner for such delay/ or any other reason thereof.

1.5 No Deviation Bid

Bidder may note that Bid shall be submitted on the basis of “NO DEVIATION” and shall be in full compliance to the requirements of Tender Document. The bids with deviations shall be considered as non-responsive and may be liable for rejection. The undertaking in this regard shall be submitted at **Attachment-8**.

- 1.6 At any time before the submission of Bids, SGEL may modify/ amend the Tender document and extend the last date of submission/opening of the Bid and any other key dates by issuing a corrigendum/addendum and such corrigendum/addendum to this notice as well as to the Tender document shall be made available to the Bidders through respective website. Any Corrigendum /Addendum thus issued shall form part of tender document. To give prospective bidders reasonable time in which to take an addendum into account in preparing their bids, the Employer shall extend, as necessary, the deadline for submission of bids.
- 1.7 The bids submitted by the bidders shall remain valid for acceptance for a period of one hundred eighty (180) days from the date of opening of bids. If any Bidder withdraws his bid before the said period or makes any modifications in the terms and conditions of the bid, the Employer shall cancel the bid.
- 1.8 Bids other than e-tenders shall not be accepted.
- 1.9 All the Bidders shall enter into an Integrity Pact (as per given format) with the Employer at the time of submission of Bids. Successful Bidder shall submit duly executed Integrity Pact on Non-Judicial Stamp Paper of appropriate value prior to signing of Contract Agreement.
- 1.10 SGEL reserves the right to reject any or all bids or cancel/withdraw the Notice Inviting Tender (NIT) and annul the process at any time prior to the issuance of letter of Award to the Successful Bidder without assigning any reason whatsoever and shall bear no liability whatsoever consequent upon such a decision.
