ORDER

(DATE OF HEARING: 17.10.2024)

1. During the hearing, Counsel for UPRVUNL apprised the Commission that instant petition was filed for approval of annual revenue requirement and determination of tariff for FY 2019-20 to FY 2023-24 for Rihand and Matatila hydroelectric power stations of UPRVUNL. However, Sh. Divyanshu Bhatt, Counsel for UPPCL, submitted that UPRVUNL has not provided any justification and documentary evidence in its petition against their claim for additional capitalization. Sh. Bhatt further submitted that UPRVUNL, in its rejoinder dated 05.09.2024, has acknowledged that at the time of tariff truing up, all expenses to be incurred would be supported by documented evidence and reconciled with the audited balance sheet. Annexures submitted by UPRVUNL along with its rejoinder dated 05.09.2024, were not legible and readable.
2. After hearing the parties, the Commission directed UPRVUNL to submit legible and readable copy of all annexures, which were submitted along with rejoinder dated 05.09.2024, and also submit documentary evidence to substantiate their claim for additional capitalization within three weeks.
