2. Biddersmustfulfill the eligibility criteria as mentioned below to participate in the tender.

a) Similar Work Experience:

The bidders who have successfully completed similar work(s) within 7 years ending on 30thSeptember,2024 (any one of the following) may participate in the tender:

- (i) Single work of value not less than Rs.70.10 Crore (Rupees Seventy Crore TenLakh) onlyOR
- (ii) Two works each of value not less than Rs.43.82 Crore (Rupees Forty-three Crore Eighty-twoLakh) onlyOR
- (iii) Three works each of value not less than Rs.35.05 Crore (Rupees Thirty-fiveCroreFive Lakh) only.

b) Similar work shall mean:

"EPC execution of Solar Projects on Turnkey basis including Design, Supply, Installation, Testing and Commissioning of Grid connected Solar PV Power Plant(s)" of

(i) single work each of capacity not less than 8 MW (AC).

OR

(ii) two works each of capacity not less than 6 MW (AC).

OR

- (iii) three works each of capacity not less than 4 MW (AC).
 - 1. Copy of work order(s) & respective satisfactory completion certificate(s) must be furnished by the bidder in Technical Bid in support of eligibility.
 - 2. In case of work experience issued by Private Organization, the bidder has to submit the TDS certificate in addition to the work experience certificate and the TDS deposited for each work separately duly certified by CA. In case of work having been executed in Paradip Port Authority, the submission of completion certificate against any work order is optional.
 - 3. In case the bidder wants to meet the eligibility criterion through its own power plant, then a certificate from the Chartered Accountant to that effect will be required to be submitted.
 - 4. Further, if the bidder participates in this tender in its individual capacity but produces the work experience credential issued to a Joint Venture (JV) firm in which the bidder was a partner, the bidder shall have to submit the copy of the concernedJV document in order to find out the exact nature, quantum and value of work(s) executed by the bidder in the JV.

c) Financial Turnover:

The bidder must have an average annual turnover of Rs.26.29 Crore (Rupees Twenty-SixCrore Twenty-nine Lakh) only or more during last 03 (Three) financial years ending on 31st March,2024. The supporting documents related to financial capabilities shall be certified by C.A / affidavit to be executed for the said supporting documents.

- d) The bidder should have (i) EPF Registration Certificate (ii) ESI / Mediclaim Policy / Employment injury & Compensation. If the bidder is having any type of Mediclaim Policy or Employment injury & Compensation scheme other than ESI, then the firm has to submit an undertaking that if the work is awarded in their favour then the firm would get registered under the ESI Scheme. (iii) Permanent Account Number [PAN] (iv) Income Tax Return of preceding three years and (v) GST Registration Certificate.
- e) The bidder has to submit duly filled in Appendix 02 and Appendix 03 of Vol.I.
- 2. The Bidder must undertake to execute the installation and commissioning of the supplied equipments, inclusive of obtaining statutory clearance to charge the equipment through an Electrical Contractor having valid HT Electrical Contractor's License issued by the Electrical Licensing Board (ELBO), Govt. of Odisha. The Bidder shall further

- undertake that the details of such HT Electrical Contractor shall be shared with Paradip Port Authority prior to taking up any such work.
- 3. The prescribed Tender Document will be available in the website: eprocure.gov.in/eprocure/app from 16:00 Hrs., dt.17/10/2024 to 18:00 Hrs., dt.20/11/2024 for online bidding.
- **4.** The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III. Those bidders not registered in the above mentioned website are required to get themselves registered beforehand with valid DSC.
- 5. Bids shall be received only "Online" on or before Dt.20/11/2024 up to 18:00Hrs.
- 6. Bids received online shall be opened at 12:00 Hrs. on Dt.21/11/2024. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. In the event of the specified date of bid opening being declared a holiday for Paradip Port Authority, the bids shall be opened at the appointed time on the next working day and same place.
- 7. Cost of Tender document and EMD shall be deposited as per Clause No.13 & 17 of ITB. A self-signed copy of acknowledgements shall be uploaded by the bidder to the portal in designated place (Ref: Clause No.15 of ITB) while submitting his / her bid in respect of documents regarding EMD and Tender paper cost. Bidder is also requested to mention the e-TCN No. in acknowledgements. If the Bidder fails to upload scanned copy of self-signed acknowledgement, his / her bid shall be declared as non-responsive and rejected. Bid shall also be accompanied by scanned copies of all relevant "Certificates / documents" as per requirement of the tender and the same shall be uploaded to the portal in the designated place of technical bid (Ref. Cl. No. 15 of ITB).
- **8.** (i) The Bidder must go through the Cl. # 67 of Special Conditions of Contract (S.C.C.) of the tender document before bidding and fill up all the Annexures as per the format.
 - (ii) The Bidder at the time of bidding shall be obliged to indicate the percentage (%) of Local Content & provide self certification as per the format enclosed as Annexure V.
