DAILY ORDER

1. The matter was kept for hearing on 25.10.2024.
2. Mr. B. R. Kharva appearing on behalf of the Petitioner MGVL submitted that the present Petition has been filed under Section 63 read with Section 86(1)(b) and other applicable provisions of the Electricity Act, 2003 seeking adoption of tariff discovered under tariff based competitive bidding process by MGVL vide RFS No. MGVL/RA&C/DSM/PM-Kusum-C-FLS/ TN-06 dated 21.03.2023 for 3 Nos. of

solar plants of total 3.0 MW, through RESCO model for solarisation of various 11 KV feeders in MGVCL for implementation of Feeder level solarisation under PM KUSUM C Scheme of Government of India.

3. He further submitted that after opening of price bid on 04.09.2023, e-reserve auction, competitive bidding process commenced on 18.09.2023.
4. On the query of the Commission that what is the tariff discovered under the aforesaid tender issued under KUSUM C scheme, he submitted that the tariff is discovered at rate of Rs. 3 per kWh for 3 MW capacity.
5. We note that the present Petition is filed by the Petitioner under Section 63 read with Section 86(1)(b) and other applicable provisions of the Electricity Act, 2003 seeking adoption of tariff discovered under tariff based competitive bidding process by MGVCL vide RFS No. MGVCL/RA&C/DSM/PM-Kusum-C-FLS/ TN-06 dated 21.03.2023 for 3 Nos. of solar plants of total 3.0 MW, through RESCO model for solarisation of various 11 KV feeders in MGVCL for implementation of Feeder level solarisation under PM KUSUM C Scheme of Government of India.
6. We also note that pursuant to the directives given by the Commission vide its Daily Order dated 12.01.2024, the Petitioner has published the public notice and invited the comments/suggestions/ objections from the stakeholders. We also note that the Petitioner has filed compliance affidavit dated 23.01.2024 before the Commission in the present matter. However, there are no comments/suggestions/ objections received in the present Petition.
7. We note that the Petitioner has filed its submissions and completed its arguments. The Petitioner is at liberty to file its further submissions, if any, within one week's

time. As submitted by the Petitioner that the pleadings in the present Petition are completed, hence we keep the matter reserved for Order.
