- 1. The matter was listed for hearing on 07.11.2024.
- 2. Shri Rakesh Inala, on behalf of the Petitioner, has submitted that GIFT Power Company Limited (hereafter referred to as 'GIFT PCL') has filed the present Petition seeking review of the Commission's Order dated 9th October, 2020 in Case No. 1851 of 2020 for truing up of FY 2013-14 to FY 2018-19 and determination of tariff for FY 2020-21 for its licensee Area.
- 3. He has further submitted that the present Petition has been filed seeking review of the impugned Order on the following grounds;
 - *A)* Actual Capitalisation for period from FY 2013-14 to FY 2018-19
 - B) O&M expenses for FY 2013-14 to FY 2018-19
 - C) Impact in Interest on Working Capital for FY 2013-14 to FY 2018-19
 - D) Additional impact of Revenue gap for FY 2013-14 to FY 2018-19
- 4. He has further submitted that in the tariff determination process, the Petitioner had submitted all desired information pertaining to Network Plan and Capital Investment

from FY 2013-14 to FY 2018-19 including Single Line Diagrams, Fixed Asset Register, copy of Contracts. He has further submitted that the staff of the Commission had undertaken field visit and verified all the installations along with the certificate issued by Chief Electrical Inspector for assets put to use/commissioned.

- 5. He has further submitted that the Commission while approving the O&M Expenses for FY 2013-14 to FY 2018-19 for the Petitioner, it had considered the process of benchmarking adopted for Capitalization of assets from FY 2013-14 to FY 2018-19 and derived the figures of O&M Expenses for GIFT PCL and allowed the same in the impugned Order.
- 6. He has requested to decide the matter as there are several judgements of Hon'ble APTEL which squarely applies to them.
- 7. We note the submission made by the petitioner. Petitioner is at liberty to file its written submissions, if any, within two weeks. The matter is now reserve for Order.
- 8. Order accordingly.
