- 1. The matter was kept for hearing on 13.11.2024.
- 2. When the matter was called out, nobody has appeared on behalf of the objector nor any written communication about their inability to remain present has been made, despite notice.

Mr. Harshesh Kakkad appearing proxy for Advocate Mr. Vishal Gupta for the Petitioner Green Infra Corporate Wind Limited, submitted that the Counsel of the Petitioner Mr. Vishal Gupta is unable to attend the hearing on account of personal difficulty and accordingly, requesting for short accommodation by adjourning the matter.
