1. The matter was kept for hearing on 13.11.2024.
2. At the outset, Ld. Adv. Mr. Yash Dadhich appearing on behalf of the Petitioner has submitted that after the hearing held on 13.06.2024, the Petitioner has filed its rejoinder vide affidavit dated 14.06.2024 and provided all relevant documents and details as sought by the Respondent in its reply.

In response to query of the Commission as to whether the issues involved in the present matter are similar and identical with the issues involved in the Petition No. 1221/2012, he submitted that the issues involved in the present Petitions No. 1365/2013, are similar and identical with the Petition No.

1221/2012. He further requested that the Commission while adjourning the matter today, may grant four weeks' time to the Petitioner to file written submissions in the matter with a copy to the Respondent.

4. Ld. Adv. Ms. Harsa Rao, appearing on behalf of the Respondent GUVNL, submitted that there is no objection to the adjournment sought by the Petitioner. She further requested the Commission to direct the Petitioner to make available the copy of rejoinder affidavit dated 14.06.2024 as the Respondent has not received the same from the Petitioner. She also requested the Commission to grant some time to GUVNL to file its written submissions in the matter.
5. Considered the submissions of Ld. Adv. Mr. Yash Dadhich appearing for the Petitioner seeking for time to file written submission in the matter. Let the same be filed within four weeks' time from the date of the hearing with a copy to the Respondent. The Petitioner is also directed to make available copy of rejoinder affidavit dated 14.06.2024 to the Respondent. The Respondent is also directed to file their written submissions, if any, within four weeks' time, from the date of hearing with a copy to the Petitioner.
