Mr. Yash Dadhich appearing on behalf of the Petitioner has submitted that after the hearing held on 13.06.2024, the Petitioner has filed its rejoinder vide affidavit dated 14.06.2024 and provided all relevant documents and details as sought by the Respondent in its reply.
