## **DAILY ORDER**

- 1. The matter was listed for hearing on 07.11.2024.
- 2. Shri Dinesh Yadav, the representative on behalf of the Petitioner, has submitted that the present Petition has been filed seeking review of Order dated 31.03.2023 passed by the Commission in Petition No. 2164 of 2022 in the matter of Truing up of FY 2021-22 and Determination of Tariff for FY 2023-24 on the ground of disallowance of increased AMC expenses under R&M expenses for FY 2023-24.
- 3. He has submitted that it had claimed an additional amount of Rs. 293.50 Lakh towards new AMC contracts that are required to be executed by SLDC for upkeep of the

equipment/software, which was considered under the subhead of R&M expenses under the head of O&M expenses for FY 2023-24. He has further submitted that the Commission did not allow under the R&M expenses and ruled that the same will be allowed as and when the same is being actually incurred. He has requested the Commission to allow the variation as uncontrollable parameter at the time of truing up exercise.

- 4. We have considered the submissions made by the Petitioner. We note that the review petition filed by the Petitioner seeking review of tariff order dated 31.03.2023 in Petition No. 2164 of 2022 passed by the Commission in respect of the issue stated in para-3 above.
- 5. We also note that this Petition has been admitted as the review petition against the impugned Order dated 31.03.2023 in Case No. 2164 of 2022 in the matter of Truing up of FY 2021-22 and Determination of Tariff for FY 2023-24 vide Daily Order dtd. 16.10.2023.
- 6. The matter is now reserved for Order.
