DAILY ORDER

1. The matter was listed for hearing on 21.11.2024.
2. Shri Dinesh Yadav, the representative on behalf of the Petitioner, has submitted that the present Petition has been filed seeking review of Order dated 01.06.2024 passed by the Commission in Petition No. 2317 of 2024 on following issues:
 - i. Disallowance of increased AMC expenses under A7G expenses for FY 2024-25
 - ii. Disallowance of capitalization for FY 2024-25

3. On query from the Commission regarding serving the copies of this petition to the original objectors of the impugned Order dated 01.06.2024 as well as impleading/joining them, he has stated that there was no objectors against the filing of Tariff Petition in the Case No. 2317 of 2024.
4. On query from the Commission regarding the grounds for the review against the impugned Order dated 01.06.2024, he has not been able to justify his contention.
5. We have considered the submissions made by the Petitioner. We note that the review petition filed by the Petitioner seeking review of tariff order dated 01.06.2024 in Petition No. 2317 of 2024 passed by the Commission in respect of the issue stated in para-2 above.
6. On perusal of the Tariff Proceedings in the Case No. 2317 of 2024, it has been observed that the Commission had not received any objections/suggestions from any of the stake holders in the matter of Truing up of FY 2022-23 and Determination of Tariff for FY 2024-25 of SLDC.
7. We, therefore, admit this Petition as the review petition against the impugned Order dated 01.06.2024 in Case No. 2317 of 2024 in the matter of Truing up of FY 2022-23 and Determination of Tariff for FY 2024-25.
8. The next date of hearing will be intimated separately.
