### **DAILY ORDER**

- 1. The matter was kept for hearing on 13.12.2024.
- 2. Ld. Adv. Mr. Aditya K. Singh on behalf of the Petitioner submitted that the present Petition is filed by the Petitioner being RE project developer and has

obtained connectivity with the transmission system of Respondent GETCO under the provisions of Electricity Act, 2003 read with the Regulations Notified by the Commission.

- 2.1. He submitted that the Petitioner is seeking reliefs for declaration with regard to unforeseen and uncontrollable events occurred affecting the creation of transmission system for evacuation of RE power from the Generating Station.
- 2.2. He submitted that the Respondent GETCO has not filed any reply to the present Petition and Petition is filed under Section 86 (1) (c) and (f) of the Electricity Act, 2003. The Commission has jurisdiction to decide the same.
- 2.3. He submitted that the time limit for completion of transmission system is 27.01.2025 and the Petitioner is seeking extension in the same due to the reason beyond the control of it. He requested that the Commission may admit the Petition and give time to the Respondent to file its reply, and the Petitioner may also be given 7 days' time for filing its rejoinder-in reply to reply filed by the Respondent and to keep the matter for hearing prior to 27.01.2025.
- 3. Ld. Adv. Ms. Ranjitha Ramachandran appearing on behalf of the Respondent GETCO submitted that the issue involves in the present Petition pertaining to extension of time limit for creation of transmission system by the Petitioner. She has no objection to admission of the Petition. Hence, the Petition may be admitted. She has also submitted that 4 weeks' time be given to file reply by the Respondent. The time limit for creation of transmission system is going to complete on 27.01.2025. Hence, the Commission may decide the date for hearing.
- 4. Heard the parties. The matter involved in the present Petition is pertaining to extension in time limit for construction and commissioning of transmission

system by the Petitioner which has been granted connectivity by the

Respondent for evacuation of 100 MW AC renewable power at 220 KV kalavad

Sub-station of GETCO. The Petitioner has submitted that they are unable to

create the transmission system to evacuation due to reasons beyond their

control. As the subject matter is pertaining to extension of connectivity granted

to the Petitioner and as the Respondent admitted that the Respondent has no

objection to admission of the Petition, accordingly we decide to admit the

Petition.

5. We also note that the Respondent has not filed any reply and has sought 4

weeks' time to file the same. The same is granted from the dated of hearing.

The Respondent is directed to file its Reply with a copy to the Petitioner. The

Petitioner is at liberty to file its rejoinder-in-reply if any, within weeks' time

from the date of receipt of reply from the Respondent.

6. We decide to keep the matter for hearing on 17/01/2025 at 11.30 hours.

7. Order accordingly.
