The bidders may download the Bidding Documents accordingly. The online bid has to be uploaded by the respective bidders at <http://eprocure.gov.in/eprocure/app> only & no other mode of participation is permitted for this tender document other than CPP Portal.
3. All future amendments/ corrigendum/ addenda/ clarifications, if any, shall be uploaded on the website <http://eprocure.gov.in/eprocure/app> only. Bidders shall keep themselves updated with all such amendments/ corrigendum/ addenda/ clarifications.
4. The Bids are invited under domestic competitive bidding from empanelled parties for this type of work in THDCIL through open tender under single stage Two-Envelope Bid System followed by e-Reverse Auction (e-RA). The first envelope (Envelope-I) called "Techno-Commercial Bid" shall contain Tender fee (if applicable), EMD, Power of Attorney & documentary evidence in support of Techno-Commercial Information. The Envelope-I (Techno-commercial Bid) and Envelope-II (Price Bid) are to be uploaded & submitted on CPP e-procurement Portal website - <http://eprocure.gov.in/eprocure/app> only in the prescribed format. No hard copy of the Price Bid shall be accepted.
5. EMD, Power of Attorney and Integrity Pact in original shall be enclosed in a sealed envelope and shall be submitted within the stipulated bid submission closing date and time in the office of THDCIL (offline) whose mailing address is mentioned in the Bid Information Sheet.
6. Bidder shall submit bid proposal along with non-refundable Tender Fees (if applicable), Earnest Money Deposit (EMD) complete in all respect as per the Bid

Information Sheet. The scan copy of the DD or scan copy of receipt of RTGS/NEFT payment detail to be uploaded & submitted with other documents. The Tender fee (if applicable) & EMD should be submitted in acceptable form only, otherwise bid may run risk of rejection. The original Bank Guarantee/ DD or details of RTGS/NEFT payment must reach on or before the last date of bid submission, at the address given in Bid information sheet. Techno-Commercial bids will be opened as per the Bid Information Sheet in offline/ online presence of authorised representatives of bidders who wish to be present offline/ online. Bid proposals received without the prescribed Tender Fee (if applicable) and Earnest Money Deposit (EMD) will be rejected. In the event of any date indicated is a declared Holiday, the next working day shall become operative for the respective purpose mentioned herein.

7. The Tender Fee and EMD is exempted for Micro and Small Enterprises (MSEs) as per prevailing Govt policies / Directives. However, the proof (the valid authenticated documents) for the same shall be submitted by the bidder for claiming the eligibility and the same must be uploaded/submitted on or before the last date of bid submission on e-portal. Bids without authentic proof of registration as Micro and Small Enterprises (MSEs), shall be treated as without Tender Fee and Bid Security shall not be entertained. Micro and small enterprises (MSEs) Units registered under Udyam registration are eligible to avail benefits under the policy.

The benefits of the Public Procurement Policy for Micro and Small Enterprise (MSEs) order 2012 can't be given to MSE bidders participating in tendering process as Joint Ventures/ Consortiums, as there is no provision of registration of Joint Ventures/ Consortiums under Udyam Registration (and earlier under UAM).

8. Conditional Bid may run the risk of rejection.
9. Notwithstanding anything stated above, THDCIL reserves the right to assess the capabilities and capacity of the bidder/ his collaborators/ associates/ subsidiaries/ group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of THDCIL.
10. THDCIL reserves the right to reject any or all the bids or cancel/ withdraw the invitation for bid, enhance or dilute the Pre-qualification criteria, in the overall interest of THDCIL, without assigning any reason whatsoever and in such case no bidder/ intending bidder shall have any claim arising out of such action.
